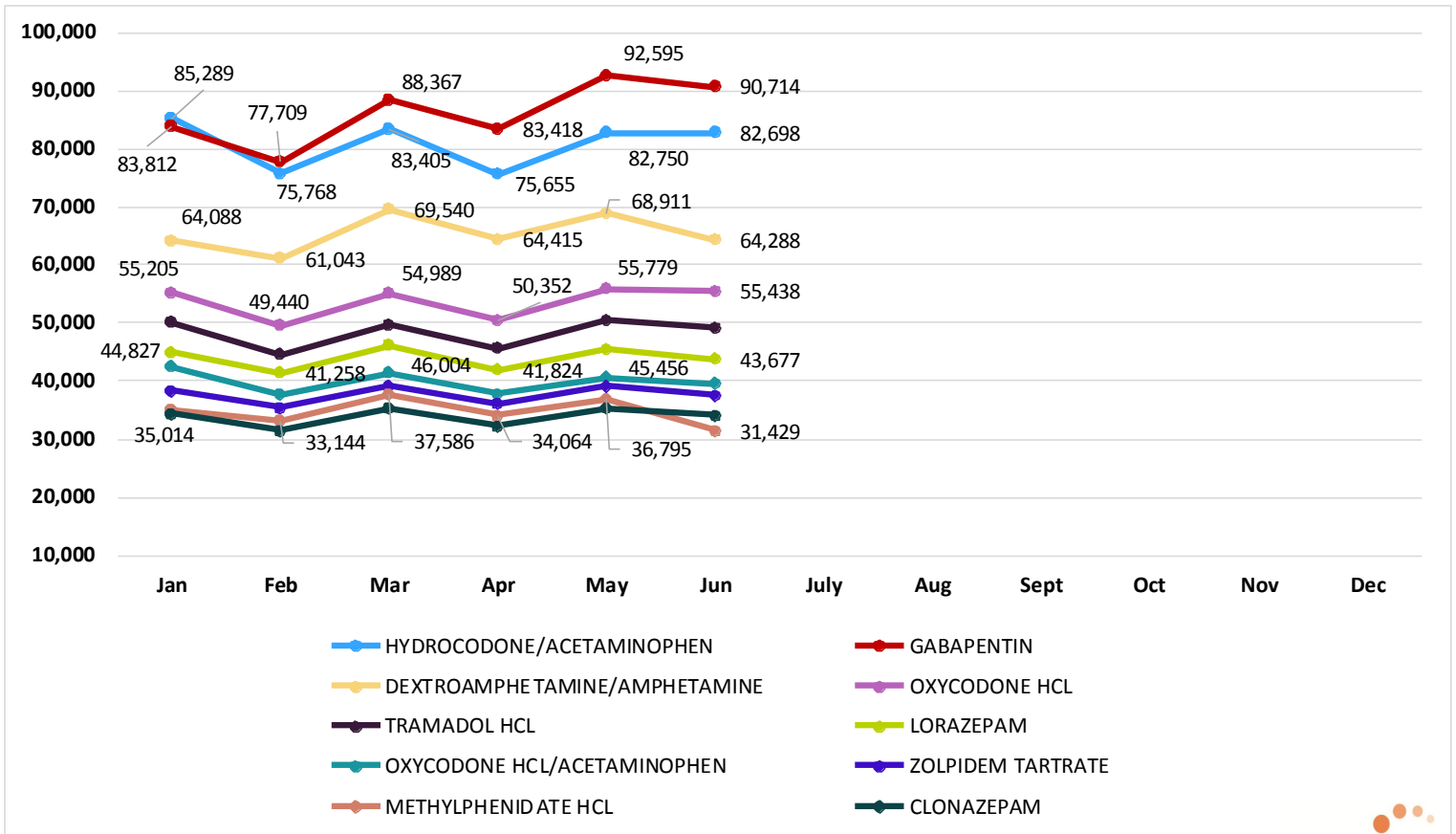

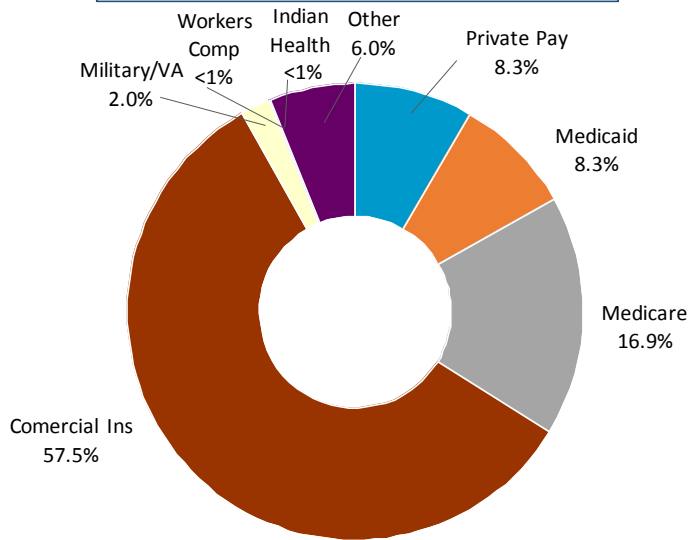

## Controlled Substance Insight Alerts

The MN PMP provides **Controlled Substance Insight Alerts (CSIA)** to prescribers and/or pharmacies regarding patients to which they have provided care and who appear to be receiving controlled substance medications from multiple prescribers and pharmacies.

### Quarter 2, Date range of CSIA: April 1, 2017 to June 30, 2017

- CSIA were sent to prescribers and/or pharmacies regarding **16** individuals
  - 2 individual met the threshold more than one time
- CSIA were sent to **87** unique prescribers
  - 6 prescriber received >1 CSIA
- CSIA were sent to **54** unique pharmacies
  - 9 pharmacies received >1 CSIA
